The Petitioner alleges as follows:

1. The Petitioner named herein is alleged to be of the sex and age and to have the name set forth.

Process issue directed to the District Attorney of Forsyth County, The Sheriff of Forsyth County, the Clerk of Court of the Forsyth County Juvenile Court and other officials who may have files or records pertaining to Petitioner's previous adjudication, giving notice of the Petition for Sealing of Records and requiring each to show cause, if any, why this petition should not be granted; and
 - b. This Court enter an order directing that Petitioner's records and files of whatever nature, wherever filed, be sealed according to law, that all inquiries about Petitioner's juvenile records be answered that no record exists with respect to Petitioner; and
 - c. For such other and further relief as this Court may deem just and proper.
