ADMINISTRATIVE ORDER NO. 16- 1

(Affecting the Memorandum of Agreement of the
Forsyth County Justice Information System Policy Board)

WHEREAS, the Forsyth County Justice Information System Policy Board was established in July 2004 to identify a comprehensive integrated justice information system to facilitate the sharing and exchange of information among Forsyth County justice system agencies and departments;

WHEREAS, the Forsyth County Justice Information System Policy Board recommended to the Board of County Commissioners the acquisition of "Odyssey," Tyler Technologies' integrated courts and justice software application;

WHEREAS, the Forsyth County Justice Information System Policy Board guided the design and development of Odyssey;

WHEREAS, the Forsyth County Justice Information System Policy Board has succeeded with implementation and deployment of the Odyssey software application which has improved the quality, consistency, and coordination of the Forsyth County justice system;

WHEREAS, seventy percent of the Forsyth County Justice Information System Policy Board is comprised of elected and public officials who no longer occupy the office which confers voting membership:

1. Jack Conway, Forsyth County Board Chairman
2. Chief Judge Philip Smith, State Court
3. Joyce Hawkins, Forsyth County Probate Court
4. Barbara Cole, Forsyth County Magistrate Court
5. Leslie Abernathy, Forsyth County Solicitor General
6. Doug Sorrells, Forsyth County Clerk of Court
7. Ted Paxton, Forsyth County Sheriff

WHEREAS, the Forsyth County Justice Information System Policy Board has now completed its work and should be dissolved;

THEREFORE, IT IS ORDERED that the Forsyth County Justice Information System Policy Board is disbanded and closed, effective upon date of this Order.

IT IS FURTHER ORDERED that the Forsyth County justice system agencies and departments continue their oversight of Odyssey on the following directives:


1. The Justice System Coordinating Committee (JSCC) will provide the forum for justice system decision makers to address Odyssey-related issues, and
2. A JSCC Criminal Justice Information Technology Subcommittee will be established to identify common goals and priorities, implement strategies, and monitor performance in an effort to improve the overall efficiency and effectiveness of the Odyssey software application for the criminal justice system.

The JCSS Criminal Justice Information Technology Subcommittee will be comprised by the following Forsyth County elected officials:

- 1) Judge David L Dickinson, Superior Court – Chair
- 2) Judge Russell McClelland, State Court – Vice Chair
- 3) Judge Walker Bramblett, Magistrate Court
- 4) Penny Penn, Forsyth County District Attorney
- 5) Bill Finch, Forsyth County Solicitor General
- 6) Greg Allen, Forsyth County Clerk of Courts
- 7) Duane Piper, Forsyth County Sheriff

This directive does not supersede any authority under the Information Systems & Technology Governance Council (ITCG). The Justice System Coordinating Committee will be the “community of interest” for the ITGC.
