**ADMINISTRATIVE ORDER 16- 4
(Amending Administrative Order 15-8 and 15-13)**


By Administrative Orders 15-8 and 15-13, the Superior and State Courts established procedures governing the use of a security surveillance camera system that digitally records audio and visual information of activity inside and outside the Forsyth County Courthouse.

1. Prior to March 21, 2016, Forsyth County Government controlled and managed the security surveillance camera system that monitored activity inside and outside the Forsyth County Courthouse.
2. Beginning March 21, 2016, the Forsyth County Sheriff's Office will assume control and management of the security surveillance camera system.


IT IS ORDERED, that Superior and State Court Administrative Orders 15-8 and 15-13 be amended to reflect that the Forsyth County Sheriff's Office now possesses control and management of the security surveillance camera system.

IT IS FURTHER ORDERED, that the Forsyth County Sheriff's Office shall adhere to the procedures set forth in Superior and State Court Administrative Orders 15-8 and 15-13 governing the use of a security surveillance camera system.
