**IN RE: ORDER APPOINTING NEW CHAIRMAN AND DESIGNATING PROXY
MEMBER FOR THE COURT TECHNOLOGY COMMITTEE**

ADMINISTRATIVE ORDER NO. 12

Considering recent changes in judicial responsibilities and to ensure the continued efficient operation of the Court Technology Committee, the following order is hereby enacted:

WHEREAS, Judge David L. Dickinson has dutifully served as the Chairman of the Court Technology Committee with distinction and commendable dedication;

WHEREAS, Judge David L. Dickinson has been appointed to serve as the Administrative Judge for the Ninth Judicial Administrative District for a term of two years, a role that carries increased duties and responsibilities;

WHEREAS, the effective stewardship of the Odyssey case management system is crucial to the administration of justice within Forsyth County;

IT IS HEREBY ORDERED as follows:

CHAIRMAN APPOINTMENT:

State Court Chief Judge T. Russell McClelland is hereby appointed as the Chairman of the Court Technology Committee, succeeding Superior Court Judge David L. Dickinson. Judge Chief Judge T. Russell McClelland shall assume all responsibilities and duties as outlined in the Committee's bylaws, including but not limited to presenting the agenda, ensuring the orderly discussion of issues, overseeing the voting process, and serving as the spokesperson for the Committee.

DESIGNATION OF PROXY:

The Circuit Court Administrator of Forsyth County is hereby designated as the proxy member for the Superior Court on the Court Technology Committee. In this capacity, the Circuit Court Administrator shall attend meetings and perform duties as necessitated by the absence or unavailability of the designated Superior Court member.


RESPONSIBILITIES OF THE CHAIRPERSON AND PROXY:

The new Chairman and the designated proxy are charged with the continuation of all strategic, operational, and collaborative functions required by the Committee to meet its objectives effectively. This includes leading the evaluation of funding needs, articulating project visions, setting quality benchmarks, reviewing system performance, and providing leadership in technological enhancements within the justice system of Forsyth County.

IMPLEMENTATION:

This order shall take effect immediately upon its issuance and shall remain in effect until further order.
