**CIVIL:** PLEASE *E-FILE* all proposed orders, consent judgments, rule nisi, default judgments. You no longer need to send these documents to the below email address, as we have a document management system that automatically notifies us as to when these types of documents are e-filed.

This email address is a "shared" mailbox and is to be used only for submitting documents not associated with an immediate hearing, such as proposed Orders, Consent Orders, etc. All documents sent to this email address are reviewed by the judge's staff before submission to the judge for signature.

**DOCUMENTS USED IN CRIMINAL PROCEEDINGS:**

The following documents will be submitted to [Courtroom401@forsythco.com](mailto:Courtroom401@forsythco.com) in criminal cases:

- (1) Proposed orders, including probation revocation orders, and probation waivers;
- (2) Sentences prepared by the Clerk;
- (3) Any other documents as directed during court proceedings; and
- (4) Signed "Waiver of Rights and Petition to Enter Plea of Guilty/Nolo Contendere" Forms (Petition and Waiver Form) and Plea Offer Sheets to be submitted by the State after all plea paperwork has been completed and signed as provided below.

**IMPORTANT INFORMATION REGARDING PLEAS!** Defense counsel or defendant, if not represented by counsel, must submit all signed plea paperwork to the assigned prosecutor prior to the court date. The prosecutor will submit the fully executed Petition and Waiver Form and the Plea Offer Sheet to [Courtroom401@forsythco.com](mailto:Courtroom401@forsythco.com) at least two (2) business days prior to the scheduled hearing court date. The prosecutor will also be responsible for e-filing the remaining fully executed plea paperwork with the Clerk on or before the scheduled hearing date.

**EXHIBITS and JURY CHARGES (Civil and Criminal)**

All exhibits to be tendered at an in-person court hearing or virtual court hearing must be copied to opposing counsel and submitted to the [Courtroom401@forsythco.com](mailto:Courtroom401@forsythco.com) address no later than 5:00 p.m. on the business day immediately preceding the date of the hearing. Acceptable formats are PDF, JPG, PNG, and MP4. No other file types will be accepted.

Each exhibit should be submitted as a separate document and separately labeled, but may be transmitted in one email, subject to the county's space limitations for email attachments. The subject line of the email should contain all the information required above, plus the Exhibit number(s) being submitted.
